More than 80 private sector members are expected to be a part of the LCDC organization in 2017. In addition to funding from Leavenworth County and the cities of Basehor, Leavenworth, Lansing and Tonganoxie, LCDC relies on continued support from the private sector because more than 17% of the operating budget comes from these local business partners. Grow Leavenworth County Issues First Check



Late last year, the city of Leavenworth's E-community program



expanded county wide. Under the new title of Grow Leavenworth County, the first check (for the first loan) approved by the Lansing/Leavenworth County Board of Grow Leavenworth County was presented to Platinum Automotive Repair, LLC.

In February, the check was presented to Matt and Vanessa Reid at Platinum Automotive Repair, 105 W Gilman Road, Suite B (just south of Leavenworth-Lansing Nursery, next to Oasis Pools).

The check was presented by Wendy Scheidt, Executive Director of the Leavenworth Main Street Program. In attendance were members of Grow Leavenworth County, and Lansing City Administrator Tim Vandall.

Grow Leavenworth County Development Corporation is a NetWork Kansas E-Community member and makes loans to entrepreneurs for new business expansion within Leavenworth County. E-community loans cannot exceed \$45,000. Terms of the Zero percent loans cannot exceed 96 months. By statute, the Network Kansas Program requires 40 percent matching funds from a public source, such as a City, County, Main Street Incentives Without Walls Microloans or a financial institution bank loan.

LCDC Micro-Grant Program

Since its inception last fall, the LCDC Micro-grant program has awarded four companies micro-grants ranging from \$300- \$1200. Recipients have been:

- Platinum Auto motive Repair (Lansing)
- American Family Insurance-Trent Peter Agency (Lansing)
- Life Family Chiropractic (Leavenworth)
- Fun and Fabulous Floral and Gifts (Tonganoxie)

The LCDC micro-grant program is designed for small business expansions and start-ups located in Leavenworth County. The applicant must be a for-profit business with less than 15 employees and less than \$500,000 in annual revenue. A company match equal to or greater than the grant request amount is required.
